President's Reports

- Cherie held scheduled weekly Zoom planning meetings for (¡Viva! The Arc of Katy 2024 Fiesta) committees and assigned tasks to Board Members. A meetings were held on Mondays, with the final meeting on February 19, 2024.
- February meeting moved to the 26th, due to date of Fiesta.

COMMITTEE REPORTS

Finance Committee

• Cash Flow for January is a gain of \$11,164. Operating Income of \$4,517 combined with fundraising of \$3,506 resulting in a net income of \$8,023. Fundraising was solely due to contributions of \$3,506. Monthly

Income was \$8,023 was higher than the budget due lower Program expenses (salaries) offset by lower fundraising.

- Year to date cash flow is positive \$23,078. The positive variance of \$26,988 is primarily due to higher tuition, lower salaries, admin expenses.
- Restricted funds currently have a \$59,755 balance with \$5,000 for security and \$55,000 for a van.
- Cash balance is \$152,711, down \$5,419 from last month.

Program Committee

- The policy on requiring a 30 day notice to leave or change days of attendance in the Day Program has been put in effect per decision of the Program Committee in January. This information has been added to the handbook.
- The Program Committee has been coordinating with the Staff to prepare the participants to attend the Fiesta on February 16, 2024. The participants will greet guests, and sing songs.
- Two Adirondack chairs are being painted for the Fiesta, and a participant has submitted some art for the auction.
- The Arc of Katy will be the recipient of the funds raised from the Spartan Games from Seven Lakes
- The Arc of Katy will have a table with materials at the Family to Family Conference on February 28th
- The Arc of Katy Social for March will be a Rodeo Dance, held at the Mark Chapman YMCA.
- The Barn Dance will be on April 20, 2024, at the Jordan Ranch location.
